

ESG GUIDING PRINCIPLES LICENSE AGREEMENT

This **ESG Guiding Principles License Agreement** (this “**Agreement**”), is agreed to between you as an individual or, if you are accessing or using the ESG Guiding Principles (defined below) on behalf of another individual, organization, or entity (each, an “**Entity**”), that Entity (in either case, “**You**” or “**Your**”) and Green Builder Media, LLC (“**GBM**”). This Agreement governs Your use of the environmental, social, and governance (ESG) guiding principles for the construction industry, as published by GBM at <https://www.greenbuildermedia.com/esg-for-building> (this webpage or any successor webpage, the “**ESG Webpage**”) (the “**ESG Guiding Principles**”). You and GBM agree as follows:

BY ACCESSING OR USING ANY PART OF THE ESG GUIDING PRINCIPLES, OR BY TICKING A BOX OR OTHERWISE INDICATING YOUR ACCEPTANCE TO THIS AGREEMENT (E.G., CLICKING “I AGREE”), YOU AGREE TO ENTER INTO AND BE BOUND BY THIS AGREEMENT. IF YOU ARE ENTERING INTO THIS AGREEMENT ON BEHALF OF AN ENTITY, BY ACCESSING OR USING ANY PART OF THE ESG GUIDING PRINCIPLES, OR BY TICKING A BOX OR OTHERWISE INDICATING YOUR ACCEPTANCE TO THIS AGREEMENT, YOU REPRESENT AND WARRANT THAT YOU HAVE AUTHORITY TO BIND THAT ENTITY TO THIS AGREEMENT. IF YOU DO NOT HAVE SUCH AUTHORITY, OR YOU DO NOT AGREE TO BE BOUND BY THIS AGREEMENT, DO NOT TICK A BOX OR OTHERWISE INDICATE YOUR ACCEPTANCE TO THIS AGREEMENT OR ACCESS OR USE ANY PART OF THE ESG GUIDING PRINCIPLES.

1. LICENSE. Subject to the terms and conditions of this Agreement, GBM hereby grants to You during the term of this Agreement a non-exclusive, non-transferable, non-sublicensable license solely to access and use the ESG Guiding Principles for Your internal business purposes only. GBM reserves all rights not expressly granted to You under this Agreement. No use by GBM of the ESG Guiding Principles in any medium or manner will be deemed to interfere with the limited permissions made to You by GBM herein.

2. RESTRICTIONS ON USE. You shall not, and You shall not permit any third party to: (a) translate, recast, edit, alter, modify, reproduce, or create any derivatives (including derivative works) of the ESG Guiding Principles; (b) copy, distribute, sell, resell, lend, loan, lease, license, sublicense, transfer, or otherwise make available to any third party the ESG Guiding Principles without GBM’s express prior written consent in each case (except that You may share a copy of the ESG Guiding Principles with any of Your employees, contractors, or authorized representatives who both (i) have a need to know the ESG Guiding Principles in connection with Your use of same for Your internal business purposes as permitted hereunder, and (ii) have agreed to be bound by the terms of this Agreement); (c) alter, obscure, or remove any copyright, trademark, or any other notices that are provided on or in connection with the ESG Guiding Principles; (d) access or use the ESG Guiding Principles in order to build or improve a competitive product, service, or other offering (whether now or hereafter existing); or (e) claim or imply that the ESG Guiding Principles belong to You or any third party. GBM has not verified the accuracy of, and will not be responsible for any errors or omissions in, the ESG Guiding Principles. You are solely responsible for Your use of the ESG Guiding Principles and You shall be and remain liable and responsible for all acts and omissions of Your employees, contractors, and authorized representatives with respect to the ESG Guiding Principles (including any of their use thereof) as if they were Your acts or omissions hereunder. If You would like to share a copy of the ESG Guiding Principles with a third party, You shall: (x) direct each such third party to the ESG Webpage; and (y) not otherwise share, distribute, sell, resell, lend, loan, lease, license, sublicense, transfer, or otherwise make available the ESG Guiding Principles except to the limited extent otherwise expressly permitted in subpart ‘(b)’ of this Section. You acknowledge and agree that: (1) all access to or use of the ESG Guiding Principles is subject to this Agreement; and (2) accordingly, regardless of how You access or otherwise obtain the ESG Guiding Principles (e.g., via access to or download from the ESG Webpage, receiving a copy from a GBM or a third party), You must agree to be bound by the terms of this Agreement before You can access or use the ESG Guiding Principles in any way.

3. OWNERSHIP AND PROTECTION. Except for the licenses expressly granted to You in this Agreement, You acknowledge that all right, title, and interest including all IPR, in and to the ESG Guiding Principles and any additions, improvements, updates, derivatives (including derivative works), and modifications thereto, are owned by GBM. If You acquire any rights in any of the foregoing by operation of law or otherwise, You hereby irrevocably assign such rights to GBM without further action by either party. You agree not to dispute or challenge or assist any person or entity in disputing or challenging GBM’s rights in and to the ESG Guiding Principles, or any additions, improvements, updates, derivatives (including derivative works), or modifications thereto. For purposes of this Agreement, “**IPR**” means all intellectual property rights, proprietary rights, rights of publicity, rights of privacy, and any and all other legal rights protecting data, information, or intangible property throughout the world, including any and all copyrights, trademarks, service marks, trade secrets, patent rights, moral rights, sui generis rights in databases, and contract rights.

4. REPRESENTATIONS AND WARRANTIES. You represent and warrant to GBM that: (a) You have the legal right and authority to enter into this Agreement; (b) this Agreement forms a binding legal obligation on Your behalf; (c) You have the legal right and authority to perform Your obligations under this Agreement and to grant the rights and licenses described in this Agreement; and (d) Your use of and access to the ESG Guiding Principles will comply with all applicable laws, rules, and regulations and will not cause GBM itself to violate any applicable laws, rules, or regulations.

5. DISCLAIMERS. THE ESG GUIDING PRINCIPLES ARE PROVIDED “AS IS” AND “AS AVAILABLE.” GBM AND ITS PROVIDERS DO NOT WARRANT OR GUARANTEE THE ACCURACY, COMPLETENESS, ADEQUACY, OR CURRENCY OF THE ESG GUIDING PRINCIPLES AND DO NOT ENDORSE THE VIEWS OR OPINIONS THAT MAY BE EXPRESSED OR PROVIDED THROUGH THE ESG GUIDING PRINCIPLES. GBM AND ITS PROVIDERS EXPRESSLY DISCLAIM ANY AND ALL WARRANTIES AND REPRESENTATIONS OF ANY KIND WITH REGARD TO THE ESG GUIDING PRINCIPLES AND

THIS AGREEMENT, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY, TITLE, AND NON-INFRINGEMENT. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY GBM, ITS EMPLOYEES, CONTRACTORS, PROVIDERS, OR AGENTS, OR THE ESG GUIDING PRINCIPLES, WILL INCREASE THE SCOPE OF, OR CREATE ANY NEW WARRANTIES IN ADDITION TO, THE WARRANTIES EXPRESSLY SET FORTH IN THIS SECTION (IF ANY). YOU UNDERSTAND AND AGREE THAT THE ESG GUIDING PRINCIPLES (IN WHOLE OR IN PART) ARE NOT INTENDED TO, AND DO NOT, REPLACE OR ENSURE YOUR COMPLIANCE WITH ANY ENVIRONMENTAL, SOCIAL, GOVERNANCE, OR INDUSTRY STANDARDS OR REQUIREMENTS. GBM SHALL HAVE NO OBLIGATION OR RESPONSIBILITY RELATING TO THE ESG GUIDING PRINCIPLES.

6. LIMITATION ON LIABILITY. GBM AND ITS PROVIDERS SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, EXEMPLARY, OR CONSEQUENTIAL DAMAGES, HOWEVER CAUSED, UNDER ANY THEORY OF LIABILITY, WHETHER IN CONTRACT, STRICT LIABILITY, OR TORT (INCLUDING NEGLIGENCE OR OTHERWISE), ARISING IN CONNECTION WITH OR OUT OF THE USE OF OR ACCESS TO THE ESG GUIDING PRINCIPLES, EVEN IF SUCH PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY LOSS OF OPPORTUNITY, REVENUES, OR PROFITS, BUSINESS INTERRUPTION, OR PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES. GBM'S TOTAL CUMULATIVE LIABILITY IN CONNECTION WITH THIS AGREEMENT AND GBM'S PROVISION OF THE ESG GUIDING PRINCIPLES, WHETHER IN CONTRACT OR TORT OR OTHERWISE, WILL NOT EXCEED USD \$100. YOU AGREE THAT GBM WOULD NOT ENTER INTO THIS AGREEMENT WITHOUT THESE LIMITATIONS ON ITS LIABILITY. IN JURISDICTIONS WHERE LIMITATION OF LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES IS NOT PERMITTED, GBM'S LIABILITY IS LIMITED TO THE MAXIMUM EXTENT PERMITTED BY LAW.

7. INDEMNITY. You hereby agree to indemnify, defend, and hold harmless GBM and its officers, directors, shareholders, affiliates, employees, agents, contractors, assigns, users, customers, providers, licensees, and successors in interest ("**Indemnified Parties**") from any and all claims, losses, liabilities, damages, fees, expenses, and costs (including attorneys' fees, court costs, damage awards, and settlement amounts) that result from any claim or allegation ("**Claim**") against any Indemnified Party arising in any manner from: (1) any access to or use of the ESG Guiding Principles by You or any of Your employees, contractors, or authorized representatives; (2) Your violation of applicable laws, rules, or regulations; or (3) Your breach of any representation, warranty, or other provision of this Agreement. GBM will use reasonable efforts to provide You with notice of any such Claim, and GBM will have the right to participate in the defense of any such Claim at its expense.

8. TERMINATION. GBM may terminate this Agreement at any time, effective upon notice to You, if You violate any term of this Agreement. Upon expiration or termination of this Agreement for any reason: (1) all rights and licenses granted to You under this Agreement will terminate; (2) You will immediately cease all use of and access to the ESG Guiding Principles; and (3) You will promptly return to GBM, or destroy (if requested), all copies of the ESG Guiding Principles in Your (including Your employees', contractors', or authorized representatives') possession or control and You will promptly permanently erase all electronic copies of such ESG Guiding Principles. The following Sections will survive any expiration or termination of this Agreement: 2 (Restrictions on Use), 3 (Ownership and Protection), 4 (Representations and Warranties), 5 (Disclaimers), 6 (Limitation on Liability), 7 (Indemnity), 8 (Termination), 9 (Modifications), and 10 (Additional Terms).

9. MODIFICATIONS. GBM reserves the right, at any time, to modify the ESG Guiding Principles, as well as the terms of this Agreement, whether by making those modifications available on GBM's website (including on the ESG Webpage) or by providing notice to You. Any modifications will be effective upon posting to GBM's website or delivery of such other notice. You may cease using or accessing the ESG Guiding Principles or terminate this Agreement at any time if You do not agree to any modification. However, You will be deemed to have agreed to any and all modifications through Your continued use of or access to the ESG Guiding Principles following such notice.

10. ADDITIONAL TERMS. Except as expressly set forth in this Agreement, this Agreement may be amended or modified only by a writing signed by both parties. Neither this Agreement nor any of Your rights or obligations under this Agreement may be assigned, delegated, or otherwise transferred, in whole or in part, by operation of law or otherwise, by You without GBM's express prior written consent. Any attempted assignment, delegation, or transfer in violation of the foregoing will be null and void. This Agreement is governed by the laws of the State of Colorado without reference to any conflict of laws principles that would require the application of the laws of any other jurisdiction. You irrevocably consent to the exclusive jurisdiction of the state and federal courts located in Denver, Colorado for any suit or action arising from or related to this Agreement. If any provision of this Agreement is, for any reason, held to be invalid or unenforceable, the other provisions of this Agreement will be unimpaired and the invalid or unenforceable provision will be deemed modified so that it is valid and enforceable to the maximum extent permitted by law. The waiver by GBM of a breach of any provision of this Agreement by You shall not operate or be construed as a waiver of any other or subsequent breach by You. This Agreement constitutes the entire agreement between the parties relating to this subject matter (i.e., the license to the ESG Guiding Principles granted to You) and supersedes all prior or contemporaneous oral or written agreements concerning such subject matter. For the avoidance of doubt, this Agreement does not supersede any Contributor Confirmation Agreement entered into by and between You and GBM. The words "include," "includes," and "including" mean "include," "includes," or "including," in each case, "without limitation." The parties hereto are independent contractors, not agents, employees, or employers of the other or joint venturers, and neither party acquires hereunder any right or ability to bind or enter into any obligation on behalf of the other. The ESG Guiding Principles or ESG Webpage may contain links to third-party sites that are not under the control of GBM. GBM is not

responsible for any content on any linked site and You access any third-party site from the ESG Guiding Principles or ESG Webpage at Your own risk.
